**2008 - 2009 HOUSE LEAGUE REGISTRATION AGREEMENT
RELEASE, INDEMNITY, AUTHORIZATION AND ACKNOWLEDGEMENT**

The North Toronto Basketball has again arranged for insurance coverage with Basketball Ontario. Under this policy, coverage is provided for all activities and operations of Basketball Ontario, all leagues, clubs, officers, directors, instructors, referees, employees and sponsors who specifically request coverage. However, the policy excludes liability insurance coverage in which a player receives an injury in the ordinary course of any NTBA basketball activity.

The Board of Directors of North Toronto Basketball Association recommends that all individuals associated with the NTBA, whether coach, player or otherwise, enquire directly with their own Home Owners Insurance Liability Coverage as to the applicability of same to their involvement in our organization and, further, to ensure that their coverage is adequate.

In consideration of North Toronto Basketball Association ("NTBA") accepting the applicant (the "Child") as a player for the 2008-2009 House League season, the parent/guardian on behalf of both the parent/guardian and the Child:

1. Herein acknowledge the risks related to the Child's participation in the sport of basketball and agrees to ensure that at all times during all NTBA basketball activities (i.e. games, warm-ups, practices etc.) the Child shall provide and wear appropriate running shoes and gym shorts or gym attire as well as the house league jersey provided by NTBA; and
2. Releases the NTBA, its directors, officers, members, coaches, referees, servants or agents for any and all claims or causes of action, for injury, loss or other related costs, howsoever caused, which the undersigned or the Child may have suffered or continue to suffer or incur as a result of the Child's participation in NTBA basketball activities; and
3. Agrees to indemnify NTBA, its directors, officers, members, coaches, referees, servants or agents and save them harmless with respect to any claim or action which may be brought against them by or on behalf of the Child and/or the Parent/Guardian from the Child's participation in NTBA basketball activities; and
4. Authorizes the NTBA, its directors, officers, members, coaches, referees, services or agents to act for the undersigned Parent/Guardian accordingly, using their best judgement in any emergency that requires medical attention and/or treatment for the Child as a result of the Child's participation in NTBA's basketball activities.
5. Acknowledges that NTBA maintains insurance coverage through Basketball Ontario as provided above.
6. Acknowledges that NTBA will assign or re-assign (i.e. trade) players to teams at its' own discretion. All players must play strictly within their age group.

THIS ACKNOWLEDGEMENT OF THE ABOVE NOTED RELEASE, INDEMNITY, AUTHORIZATION AND ACKNOWLEDGEMENT CLAUSES MUST BE FULLY COMPLETED AND SIGNED BELOW AS ACCEPTANCE OF THE TERMS AND CONDITIONS HEREIN IN ORDER TO QUALIFY THE CHILD TO PARTICIPATE IN THE RESPECTIVE ACTIVITIES OF NTBA.
