RELEASE, INDEMNITY, AUTHORIZATION AND ACKNOWLEDGEMENT

In consideration of the NTBA's acceptance of your child (the "Child") as a participant in the NTBA 2011-2012 Rep program, the Parent/Guardian on behalf of both the Parent/Guardian and the Child (if under 18 years of age):

1. Herein acknowledges the risks related to the Child's participation in the sport of basketball, which risks include severe injury and death, and agrees to ensure that at all times during the Child's participation in the NTBA 2011-2012 Rep program (including practices, scrimmages, games, workout sessions and warm up/cool down) the Child shall be provided with and wear appropriate court shoes and gym shorts or gym attire; and

2. Releases the NTBA, its directors, officers, members, coaches, referees, servants and agents from any and all claims and causes of action for any injury, loss, pain and suffering, or other damages or related costs of any kind whatsoever, howsoever caused, which the undersigned and/or the Child suffers or incurs as a result of the Child's participation in the NTBA 2011-2012 Rep program; and

3. Agrees to indemnify and hold harmless NTBA, its directors, officers, members, coaches, referees, servants and agents with respect to any claims or causes action whatsoever which may be brought against them by or on behalf of the Child and/or the Parent/Guardian as a result of the Child's participation in the NTBA 2011-2012 Rep program; and

4. Authorizes the NTBA, its directors, officers, members, coaches, referees, servants and agents to act for the undersigned Parent/Guardian accordingly, using their best judgement in any emergency that requires medical attention and/or treatment for the Child as a result of the Child's participation in the NTBA 2011-2012 Rep program.

5. PHOTO RELEASE AND INDEMNITY - The NTBA is authorized to take photographs of my child or me at its programs for publicity and promotional purposes only. I, the undersigned Parent or Guardian hereby consents to the publication and use by the NTBA of any such photographs for publicity and promotional purposes on the NTBA web site or other marketing initiatives.

6. Acknowledges that NTBA maintains insurance coverage through Basketball Ontario.
